Martin Fuhrmann new member of the Management Board of the voestalpine Group's High Performance Metals Division

After completing his studies in social and economic sciences at the Vienna University of Economics and Business Administration (WU), Martin Fuhrmann began his professional career in the retail division of a large European electronics retailer and then moved to the Austrian branch of a leading global logistics company as Head of Controlling. In 2005, he joined the former Böhler-Uddeholm IT subsidiary "Intesy" as Head of Controlling. Between 2008 and 2014, he held various management positions in the voestalpine Böhler Welding Group. In 2014, Martin Fuhrmann took over as Managing Director of voestalpine High Performance Metals International GmbH and Head of the International Region within the Sales and Service Division.

"In my new role as a member of the Management Board of the High Performance Metals Division, I am looking forward to working with a highly ambitious team from different countries and cultures. The High Performance Metals Division is incredibly diverse, both in terms of our product range and, above all, our employees. We want to utilize this strength and make it even more tangible for our customers," says Martin Fuhrmann. Born in Burgenland, he now lives near Vienna, is married and has two children.
