1 General

The offer and/or order is governed by both the project specific agreement with the customer ('the agreement'), the present sectoral general terms and conditions ('sectoral terms and conditions') and by the general terms and conditions of sale ('the general terms and conditions') of voestalpine Sadef. The agreement takes precedence over the sectoral terms and conditions and over the general terms and conditions insofar as they conflict. The sectoral terms and conditions take precedence over the general terms and conditions of voestalpine Sadef insofar as they conflict.

2 Product specifications

- The supply by voestalpine Sadef of building components for industrial buildings mainly consists of roll-formed steel sections in Sigma, Zed, Cee or U-shape, at the correct length, furnished with part numbers and the necessary holes. The general documentation on this can be found in the voestalpine Sadef documentation "Construction steel sections". This can be consulted on our website https://www.voestalpine.com/sadef/en/Infocenter.
- The sections are manufactured standard from continuous hot-dip galvanised strip steel (quality Z-275)sendzimir in accordance with EN10 346. Regarding the fittings: Bolt connecting rods can be deep-dip galvanised on request. The standard braces are steel cables and not galvanised. The customer bears sole responsibility for the complete delivery and/or validation of all correct technical data and/or studies, all environmental factors and specific data that determine the type, quality and finish of the product to be supplied by voestalpine Sadef ("the product"). If necessary, the customer will appoint an expert to prepare a report on the environmental factors (such as, without being exhaustive: studies with regard to corrosion, wind, snow, the stability of the subsoil, foundations, ...). Voestalpine Sadef cannot be held liable for any damage resulting from the use of the products in circumstances that do not correspond to the data communicated and/or validated by the customer.
- The sections are manufactured according to the voestalpine Sadef ISO instructions 109.14.001-008. These are available on request.

3 Specific design stipulations

- 1 The design of voestalpine Sadef does not take into account fire resistance, acoustic insulation, vibration, thermal insulation, seismic loads, installation sequence or installation speed.
- If the structural design has been defined by voestalpine Sadef, the production drawings and any required verification will be drawn up by voestalpine Sadef upon receipt of the signed offer. Voestalpine Sadef will start production only after written approval by the customer of the production drawings presented by voestalpine Sadef and any necessary verification. Any delay in delivery caused by a delay in customer approval is the customer's sole responsibility and cannot constitute grounds for a complaint.

4 Price

The prices stated in the offer are exclusive of VAT and import duties, installation, nuts and bolts, measurement or inspection of the site or building. Any non-standard hole patterns can be subject to a price review and/or an additional investment in tooling.

5 Delivery

4 Carriage paid deliveries are in principle consolidated. Consequently, no specific delivery time can be guaranteed. However, delivery at a specific time can be requested by the customer from voestalpine Sadef, subject to the agreement of voestalpine Sadef and subject to payment of an additional price to be agreed.

6 Liability

- The customer is fully responsible for taking adequate measures with respect to fire resistance and proper maintenance, vibration, acoustic insulation, thermal insulation, earthquakes. Voestalpine Sadef is not liable for damages resulting from a lack of such measures by the customer. The customer must also hold voestalpine Sadef fully harmless against such claims by third parties.
- Voestalpine Sadef only bears responsibility for the design of steel construction components if the relevant steel design is finalised by voestalpine Sadef and the production and supply of the construction components is carried out in full by voestalpine Sadef.

7 Installation

- 1 Installation responsibility:
 - Actual assembly is the customer's full responsibility.
 - Voestalpine Sadef is not responsible for any damage caused by missing or incorrectly installed voestalpine Sadef sections, improper installation, or lack of maintenance or incorrect use.
 - If, for whatever reason, the customer modifies the construction supplied by voestalpine Sadef without the prior written consent of voestalpine Sadef, the customer automatically assumes all responsibility with regard to the stability, functionality and performance of the voestalpine Sadef construction.
